TASK	DESCRIPTION OF ACTIVITIES
1.0 Adminstration	The progress report was submitted on June 10, 2014 for the 3rd quarter of FY2014. The report was amended to include information on the bioassessment conducted in the quarter. The corrected report was resubmitted on June 25, 2014. The invoice for the 3rd quarter was submitted on June 23, 2014. During the quarter, the GBRA lab discovered that a price increase announced in September 2013 was not correctly implemented. The TCEQ CRP Project Manager was notified of the error. An invoice to CRP, along with a letter of explanation will be submitted with the 4th qtr invoice correcting the accounting error. The Self-Assessment for FY2014 was submitted on August 28, 2014. Amendment No. 1 of the Contract became effective on June 18, 2014. The amendment provides funding to UGRA for monitoring sites that evaluate the effectiveness of control measures implemented in the Bacteria Reduction Plan (see Task 2 Description of Activities). Submitted with this progress report is the progress report from UGRA covering the months of March 2014 through August 2014.
2.0 Quality Assurance and Project Planning	Amendment #2 to the FY14-15 Quality Assurance Project Plan (QAPP) was submitted to CRP. The amendment updated Appendix B of the FY14-15 QAPP to reflect changes to the Sample Design Rationale for FY 2015, the monitoring sites table and the map of sampling sites. The UGRA Bacteria Reduction Project will end in August 2014. There are nine sites currently monitored monthly for bacteria under that project. In FY 2015 UGRA will monitor these sites, under the CRP QAPP. Bioassessments will be conducted on Plum Creek at CR135 (12640) in FY15. The objective of the assessments will be to gather data for Aquatic Life Monitoring (ALM). The monitoring type code will be reported as BS, rather than RT. Comments were received back from TCEQ. Those comments were addressed and the amendment was resubmitted on July 15, 2014. The Amendment was distributed to the entities listed in Section A3 of the QAPP on July 22, 2014. Signed acknowledgement forms for amendments 1 and 2 were submitted to the TCEQ CRP project manager on August 27, 2014.
3.0 Water Quality Monitoring	Water quality monitoring was conducted per the coordinated monitoring schedule. Dates of the sampling event are listed on the monitoring schedule included in this progress report. Turbidity for the sample collected at the Plum Creek at CR 202 site was not reported due to laboratory error (miscommunication between analysts). The corrective action report is included in this progress report. WVWA failed to record field data at site no. 12665, Blanco River at Fischer Store Road. The Corrective Action Report is pending. Depth profiles were collected on Coletto Creek on August 11, 2014. Per the coordinated monitoring schedule, the first bioassessment was conducted at the Plum Creek at CR 135 site in Caldwell County on June 26-27, 2014.
4.0 Data Management	Data for March and April 2014 was submitted on June 2, 2014. Data for May 2014 was submitted on June 26, 2014. Bioassessment data for the events conducted in 2013 was uploaded to the SWQMIS test site. The data was sent to the TCEQ project manager and reviewed. Lee Gudgell (GBRA) answered questions concerning the bioassessment data.
5.0 Data Analysis and Reporting	Hard copies of the 2014 Basin Highlights Report were sent to the basin steering committee on June 5, 2014. Required copies sent to TCEQ CRP on June 3, 2014.
