



**RESOLUTION NO. 2013 - 1**

**A RESOLUTION OF THE GUADALUPE BASIN COALITION  
CALLING ATTENTION TO CONTINUING DROUGHT  
CONDITIONS IN THE REGION, WARNING OF POTENTIALLY  
DIRE DROUGHT CONDITIONS IN 2014, AND EXPRESSING  
SUPPORT FOR IMPLEMENTATION OF THE EDWARDS  
AQUIFER HABITAT CONSERVATION PLAN**

**WHEREAS**, severe drought conditions exist in the Guadalupe River Basin and the Edwards Aquifer Region of Texas; and

**WHEREAS**, the National Weather Service Climate Prediction Center issued a prediction on August 15, 2013 that drought conditions are likely to persist in these areas into 2014; and

**WHEREAS**, the base flow of the Guadalupe, Comal and San Marcos Rivers during drought conditions consists primarily of flows from the Comal and San Marcos Springs; and

**WHEREAS**, the Edwards Aquifer Habitat Conservation Plan (EAHCP) has as a primary goal the protection of the continued flow of the Comal and San Marcos Springs; and

**WHEREAS**, if not for the EAHCP to manage the Edwards Aquifer to maintain minimum spring flows in a repeat of the drought of record to the benefit and protection of identified endangered species in the Landa and San Marcos Lakes, and Comal and San Marcos Springs systems, current groundwater law would most certainly result in cessation of springflows for long periods of time in a drought; and

**WHEREAS**, the EAHCP is still in the process of being implemented in the midst of the difficult circumstances of the current drought conditions; and

**WHEREAS**, the EAHCP's primary mechanisms for protecting the continued flow of the Comal and San Marcos Springs – the Regional Water Conservation Program, the Voluntary Irrigation Suspension Program, the San Antonio Water System Aquifer Storage and Recovery Program, and the Stage V Critical Period - all depend on reductions in use of water from the Edwards Aquifer; and

**WHEREAS**, the Edwards Aquifer Authority has announced Stage 5 of the Critical Period Management Plan for the Uvalde Pool and Stage 3 for the San Antonio Pool; and

**WHEREAS**, the Guadalupe Basin Coalition wishes to call attention to the current drought conditions, encourage regional water users and water providers to take affirmative steps to prepare for continued drought in 2014, while also expressing strong support for the continued implementation of the EAHCP; and

**WHEREAS**, whether current measures will be effective at protecting the continued flow of the Comal and San Marcos Springs in this severe drought remains to be seen, the EAHCP contains an adaptive management process that can be initiated to put measures in place that will protect the continued flow of the Comal and San Marcos Springs; now, therefore

**BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE GUADALUPE BASIN COALITION:**

**SECTION 1.** The Guadalupe Basin Coalition calls the attention of the public to the current drought conditions in the Guadalupe River Basin and the Edwards Aquifer Region of Texas, and requests that all persons, businesses and water utilities in the area be mindful of these conditions and as conservative as possible in their use of water.

**SECTION 2.** The Guadalupe Basin Coalition calls the attention of the public to the potential for the current drought to persist into 2014 and to deplete water supplies that are already strained under the current drought.

**SECTION 3.** The Guadalupe Basin Coalition strongly supports the continued implementation of the EAHCP, and in particular, the mechanisms for protecting the continued flow of the Comal and San Marcos Springs.

**SECTION 4.** The Guadalupe Basin Coalition strongly urges all users of the Edwards Aquifer to conserve water supplies for use during the current drought to protect the flow of the Comal and San Marcos Springs, especially since the EAHCP springflow protection measures are not yet fully implemented.

**SECTION 5.** If it becomes apparent that continued flow of the Comal and San Marcos Springs is being threatened to levels below those defined in the EAHCP due to the severity of this drought, the Guadalupe Basin Coalition strongly urges the parties and stakeholders in the EAHCP to initiate the EAHCP adaptive management process to put measures in place through the EAHCP that will protect the continued flow of the Comal and San Marcos Springs.

**SECTION 6.** This Resolution takes effect immediately upon adoption.
