

Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches. Turbidity is measured 4 times per day through grab samples and continuously through automatic on-line individual filter turbidity monitors.

Required Additional Health Information

In order to ensure that tap water is safe to drink, the USEPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

All drinking water, (including bottled water), may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

(A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;

(B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming;

(C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, stormwater runoff, and residential uses;

(D) Organic chemical contaminants, including synthetic and volatile organics, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems;

(E) Radioactive contaminants, which can be naturally-occurring or the result of oil and gas production and mining activities.

Special Notice

Required language for ALL community public water supplies:

Where Do We Get Our Drinking Water?

Cordillera Ranch receives its water from a water well which pumps from the Trinity aquifer and from Canyon Lake via the GBRA Western Canyon Water Treatment Plant. The water system is operated by the Guadalupe-Blanco River Authority (GBRA).

A Source Water Susceptibility Assessment for your drinking water source(s) is currently being updated by TCEQ. This information describes the susceptibility and types of constituents that may come into contact with your drinking water source based on human activities and natural conditions. The information contained in the assessment allows us to focus source water protection strategies. Trained operators monitor and test the water, including the addition of fluoride and chloramine, to ensure that our water meets or exceeds all state and federal drinking water standards. The treated water is delivered to the city's water towers and delivered through its distribution system to you. What We Found

The following tables list the contaminants that have been found in your drinking water. USEPA requires water systems to test for more than 97 contaminants. The column marked "Highest Level at Any Sampling Point" shows the highest test results during the year. The "Source of Constituent" column shows where this substance usually originates.

DEFINITIONS:

Maximum Contaminant Level (MCL) - the highest level of the contaminant allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - the level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

Action Level (AL) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

NTU - Nephelometric Turbidity Units.

ppm - parts per million, or milligrams per liter (mg/L).

ppb - parts per billion, or micrograms per liter (ug/L).

MRDL - Maximum Residual Disinfection Level.

NA - Not applicable

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. This water supply is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
