Dear Customer:

The City of Lockhart is pleased to provide you with this 2016 Water Quality Report. We take all possible precautions to safeguard your water supply and hope you will be encouraged to learn about the high quality of water provided to you.

The federal Safe Drinking Water Act (SDWA) requires water utilities to issue an annual report to customers, in addition to other notices that may be required by law. This report explains where your drinking water comes from, what it contains, and the health risks our water testing and treatment are designed to prevent.

We are committed to providing you with information about your water supply because informed customers are our best allies in supporting improvements needed to maintain the highest drinking water standards.

**We are proud to report that the Texas Commission on Environmental Quality (TCEQ) has assessed our system and determined that your drinking water meets or exceeds all federal and state established water quality standards.**

The tables in this report list all substances that were detected in our treated water, and the highest level at which they were detected. The tables also reflect the highest levels allowed by federal regulatory agencies. Please read this information carefully and if you have questions, call the numbers listed in this report.



## Required Additional Health Information

In order to ensure that tap water is safe to drink, the USEPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

All drinking water, **(including bottled water)**, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the USEPA's Safe Drinking Water Hotline (1-800-426-4791).

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

(A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;

(B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming;

(C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, stormwater runoff, and residential uses;

(D) Organic chemical contaminants, including synthetic and volatile organics, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems;

(E) Radioactive contaminants, which can be naturally-occurring or the result of oil and gas production and mining activities.

## Special Notice

### Required language for ALL community public water supplies:

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly or immunocompromised such as those undergoing chemotherapy for cancer; those who have undergone organ transplants; those who are undergoing treatment with steroids; and people with other immune system disorders can be particularly at risk for infections. ## Where Do We Get Our Drinking Water?

The City of Lockhart receives its water from two sources. Groundwater is pumped from the Wilcox Aquifer and blended with surface water from the San Marcos River treated at the GBRA Luling Water Treatment Plant, operated by the Guadalupe-Blanco River Authority (GBRA).

The TCEQ completed an assessment of your source water and results indicate that some of your sources are susceptible to certain contaminants. The sampling requirements for your water system are based on this susceptibility and previous sample data. Any detection of these contaminants may be found in this Consumer Confident Report. Trained operators monitor and test the water, including the addition of fluoride and chlorine, to ensure that our water meets or exceeds all state and federal drinking water standards. The treated water is delivered to the city's water towers and delivered through its distribution system to you. ### What We Found

The following tables list the contaminants that have been found in your drinking water. USEPA requires water systems to test for more than 97 contaminants. The column marked "Highest Level at Any Sampling Point" shows the highest test results during the year. The "Source of Constituent" column shows where this substance usually originates. In the water loss audit submitted to the Texas Water Development Board for the time period of January 2016 through December 2016, the system lost an estimated 75,391,098 gallons of water. #### DEFINITIONS:

**Maximum Contaminant Level (MCL)** - the highest level of the contaminant allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal (MCLG)** - the level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

**Action Level (AL)** - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

**NTU** - Nephelometric Turbidity Units.

**ppm** - parts per million, or milligrams per liter (mg/L).

**ppb** - parts per billion, or micrograms per liter (ug/L).

**MRDL** - Maximum Residual Disinfection Level.

**MRDLG** - Maximum Residual Disinfectant Level Goal

Total organic carbon (TOC) sampled from source water has no health effects. The disinfectant can combine with TOC to form disinfection byproducts. Disinfection is necessary to ensure that water does not have unacceptable levels of pathogens. Byproducts of disinfection include trihalomethanes (THMs) and haloacetic acids (HAA) which are reported elsewhere in this report.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. This water supply is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches. Turbidity is measured 4 times per day through grab samples and continuously through automatic on-line individual filter turbidity monitors.
