2	Canyon Reservoir less than 895 ft OR Storage facilities are less than 41% capacity	Watering with a hose-end sprinkler or irrigation system is allowed TWO DAYS PER WEEK based on the last digit of the address. Watering must occur BEFORE 10 a.m. and AFTER 7 p.m. Hand watering with a hand-held hose, drip irrigation, bucket, or watering can is allowed any time on any day.	0, 2, 4, 6 or 8	Tuesday/ Friday
			1, 3, 5, 7 or 9	Monday/ Thursday
			No address/ commercial meters	Wednesday/ Saturday
3	Canyon Reservoir less than 890 ft OR Storage facilities are less than 33% capacity	Watering with a hose-end sprinkler or irrigation system is limited to ONE DAY PER WEEK based on the last digit of the address. Watering must occur BEFORE 10 a.m. and AFTER 7 p.m. Non-public swimming pools must have a minimum of 25 percent of the surface covered and are restricted from being filled or refilled. Operation of ornamental fountains or ponds for aesthetic purposes are prohibited.	0 or 1	Monday

			No address/ commercial meter	Saturday
4	Canyon Reservoir less than 885 ft OR Storage facilities are less than 25% capacity	Watering with a hose-end sprinkler or irrigation system is limited to ONE DAY EVERY OTHER WEEK based on the last digit of the address. Watering must occur BEFORE 10 a.m. and AFTER 7 p.m. Residential washing of cars, motorcycles, boats, trailers or any other motor vehicle is prohibited. Non-public swimming pools must have a minimum of 25 percent of the surface covered and are restricted from being filled or refilled. Operation of ornamental fountains or ponds for aesthetic purposes are prohibited Customers using more than 25,000 gallons during Stage 4 will incur a 25% rate increase	0 or 1	Monday

5 Emergency	Intended for water shortage emergencies from major line breaks, system failures, natural disasters related to weather including any natural or man-made contamination of water supply sources. The following activities are prohibited: Landscape watering, washing of vehicles, and filling or refilling of swimming pools.
